1. AMENDMENTS TO ANNEX IA OF THE COMMISSION PROPOSAL

EXPLANATORY NOTE:

On Norway lobster in the Skagerrak and Kattegat (3a), the Commission proposes to set the TAC at 10 826 tonnes, in line with the MSY lower value, in order to protect cod in Kattegat, for which remedial measures have to be taken. This entails a reduction of 21%.

On Norway lobster in the Bay of Biscay (8a, 8b, 8d and 8e), the Commission proposes to set the TAC at 3 984 tonnes, in line with the MSY point value. This entails an increase of 2.5%.

For Norway lobster in the Iberian waters (9 and 10; Union waters of CECAF 34.1.1), the Commission proposes to set the TAC of 371 tonnes in line with the ICES precautionary advice, leading to a reduction of 3.9%.

For Whiting in the Bay of Biscay (8) the Commission proposes to set the TAC at 2 276 tonnes in line with the ICES precautionary advice, leading to a reduction of 10%.
