THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU) No 508/2014 of the European Parliament and of the Council of 15 May 2014 on the European Maritime and Fisheries Fund and repealing Council Regulations (EC) No 2328/2003, (EC) No 861/2006, (EC) No 1198/2006 and (EC) No 791/2007 and Regulation (EU) No 1255/2011 of the European Parliament and of the Council<sup>1</sup>, and in particular Article 114(3) thereof,

After consulting the Committee for the European Maritime and Fisheries Fund,

Whereas:

- (1) Annex I to the Commission Implementing Regulation (EU) No 1362/2014 sets out the format and presentation of the annual implementation reports for the European Maritime and Fisheries Fund in accordance with Article 50 of the Regulation (EU) No 1303/2013<sup>2</sup> and Article 114(2) of Regulation (EU) No 508/2014.
- (2) Due to the amendments to Article 70(2) of Regulation (EU) No 1303/2013 of the European Parliament and of the Council as regards costs of operations implemented outside the programme area, Annex I to the Commission Implementing Regulation (EU) No 1362/2014 should be amended accordingly.
- (3) In order to allow for prompt application of the measures provided for in this Regulation, this Regulation should enter into force on the day following that of its publication in the *Official Journal of the European Union*.
- (4) The measures provided for in this Regulation are in accordance with the opinion of the Committee for the European Maritime and Fisheries Fund,

HAS ADOPTED THIS REGULATION:

*Article 1*

Implementing Regulation (EU) No 1362/2014 is amended as follows:

- (a) Table 5 in Part A of Annex I is replaced by the following:
