#### 15:30-16:30 Emergency Management in the Arctic

Increasing interest in Arctic resources, infrastructure, transport, and tourism requires enhanced safety and security systems. However, as human activities in the region increase, hazards linked to climate change such as wildfires, floods or extreme weather also increase. This increases risks for people and the environment. Hence, civil protection, emergency preparedness and response or maritime search and rescue operations are becoming more relevant in the Arctic context. This panel focuses on how emergency response capacities can be strengthened and what is the EU's role in this process.
