

- Country-specific meetings ("trilaterals": MA/NN, DG MARE, FSU) to be scheduled around the meeting


Transnational seminars for FLAGs (sea-basin approach)

- Baltic and inland: initially planned May 2020, postponed to March 2021
 - Improving the focus of LDS
 - Facilitating FLAG cooperation
 - Creating linkages with other initiatives (Horizon 2020, Interreg etc.)
- Mediterranean and Black Sea: 25-27 Nov. 2020, on-line
 - Sea-basin challenges: sustainable tourism, protecting marine environment, SSCF, sustainable aquaculture Horizontal themes:
 - Improving quality of CLLD projects
 - COVID, linkages with other initiatives & potential funders
- Atlantic and North Sea: March 2021




Local initiatives supported by FLAGs to face the Covid-19 crisis



Survey of FLAGs actions related to algae


- to provide quantitative and qualitative information on algae-related projects funded by CLLD under the EMFF

- to improve understanding of the challenges that FLAGs perceive in supporting algaerelated activities








FLAG-funded algae project by country & project categories



FSU Green Deal survey & report objectives:


- provide knowledge base of FLAGs action, identify gaps.

Survey closed in September 2020, results expected in late 2020




FLAG actions contributing to the European Green Deal and the EU's 2030 Strategy for Biodiversity
