EUROPEAN MARITIME, FISHERIES AND AQUACULTURE FUND (EMFAF)

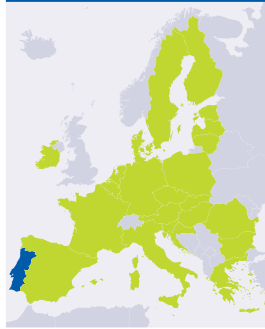
Community-led Local Development under the EMFAF in Portugal will continue to strengthen fishing and aquaculture activities and support initiatives for the growth of the blue economy. It aims to boost blue entrepreneurship and modernise fisheries and marine tourism technology and infrastructure. Fisheries Local Action Groups (LAGs) will focus their activities on supporting the creation of new businesses and opportunities to complement fishers' and fish farmers' incomes. They will also support innovation-based projects to attract young people, prioritising the empowerment and qualification of professionals in the sector, and ensuring lifelong learning for fisheries and aquaculture stakeholders.
