1. PROCUREMENT

1.1. Budget heading 11 06 63 01

- Operational technical assistance at the initiative of the Commission.

Legal basis:

- Regulation (EU) No 508/2014 of the European Parliament and Council of 15 May 2014 on the European Maritime and Fisheries Fund and repealing Council Regulation (EC) No 2328/2003, (EC) No 861/2006, (EC) No 1198/2006 and (EC) No 791/2007 and Regulation No 1255/2011 of the European Parliament and Council¹, and in particular Articles 23 and 92 thereof,
- Regulation (EU) No 1303/2013 of the European Parliament and Council 17 December 2013 laying down common provisions on the European Regional Development Fund, the European Social Fund, the Cohesion Fund, the European Agricultural Fund for Rural Development and the European Maritime and Fisheries Fund and laying down general provisions on the European Regional Development Fund, the European Social Fund, the Cohesion Fund and the European Maritime and Fisheries Fund and repealing Council Regulation (EC) No 1083/2006, and in particular Article 58 thereof.

1.1.3. IT services and supplies

Point 1.1.3 is modified as follows:

Subject matter of the contracts envisaged	Development and maintenance of IT applications to support the implementation of the EMFF and supply of hardware to support these applications.
Type of contract	Some 15 specific contracts to be awarded in accordance with the framework agreement of the Directorate-General for informatics (DIGIT).
Indicative Budget	€765.000
Implementation	Part of the appropriations will be subject to cross sub-delegation or co-delegation granted to DG EMPL and DG REGIO to fund the implementation of SFC2007, SFC2014, SFC2007 back-office and WAVE.
Indicative timetable	Specific contracts to be concluded throughout 2017.

1.1.5. Study on new assessment of administrative costs and burdens in the European Structural and Investment (ESI) Funds

Subject matter of the contracts	Revision of the baselines for administrative costs and burdens for the implementation of European Structural and Investment (ESI) Funds.
