EMFF implementation 2020

*EMFF implementation **advanced at cruising speed** despite the storm created by the COVID-19 outbreak*

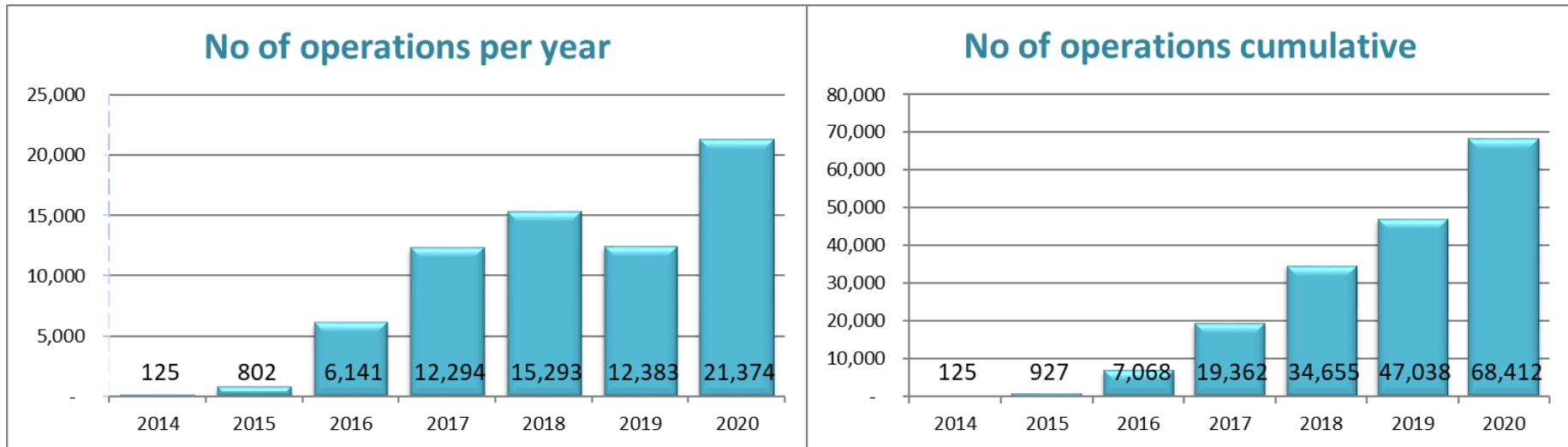
***Measures adopted helped to mitigate the negative effects** of the coronavirus crisis*

***New forms of management** – online meetings, web-based solutions as well as further easing of the administrative burden*

***Sanitary crisis** was the major challenge mentioned in AIRs*

Number of operations

The total number of operations reached 68 000

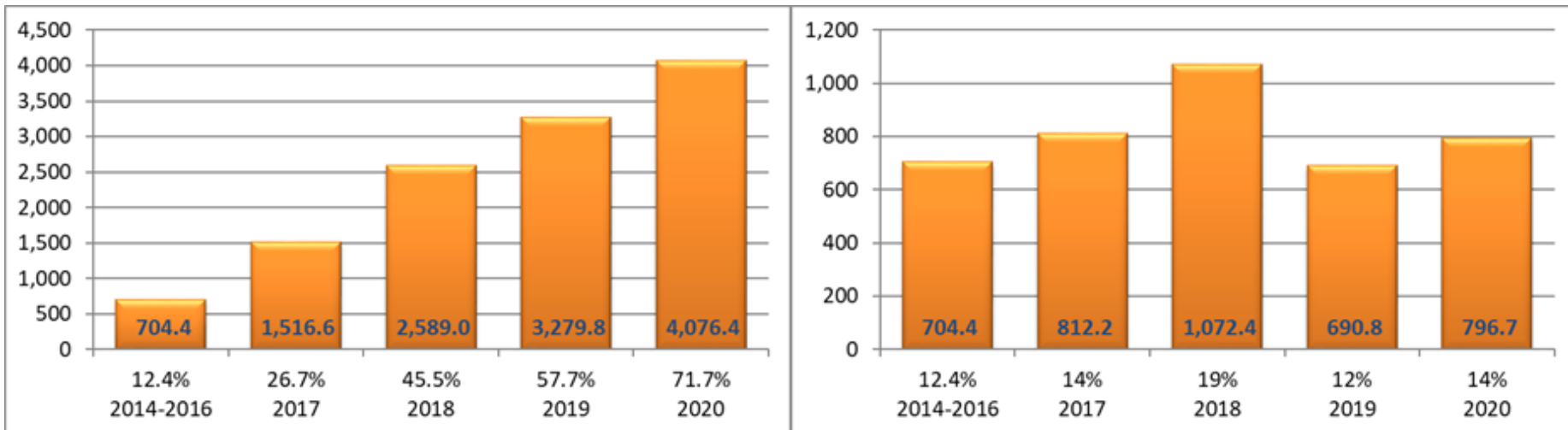


EMFF implementation – commitments

Per year



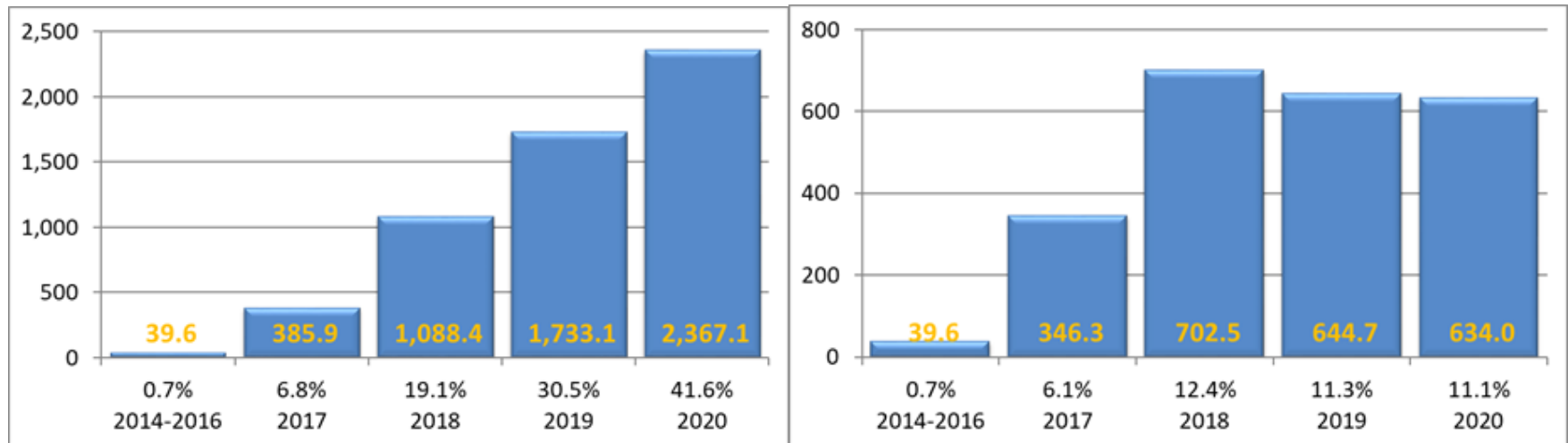
EMFF commitments as percentage of total EMFF allocation – EUR 5.7 billion

Cumulative

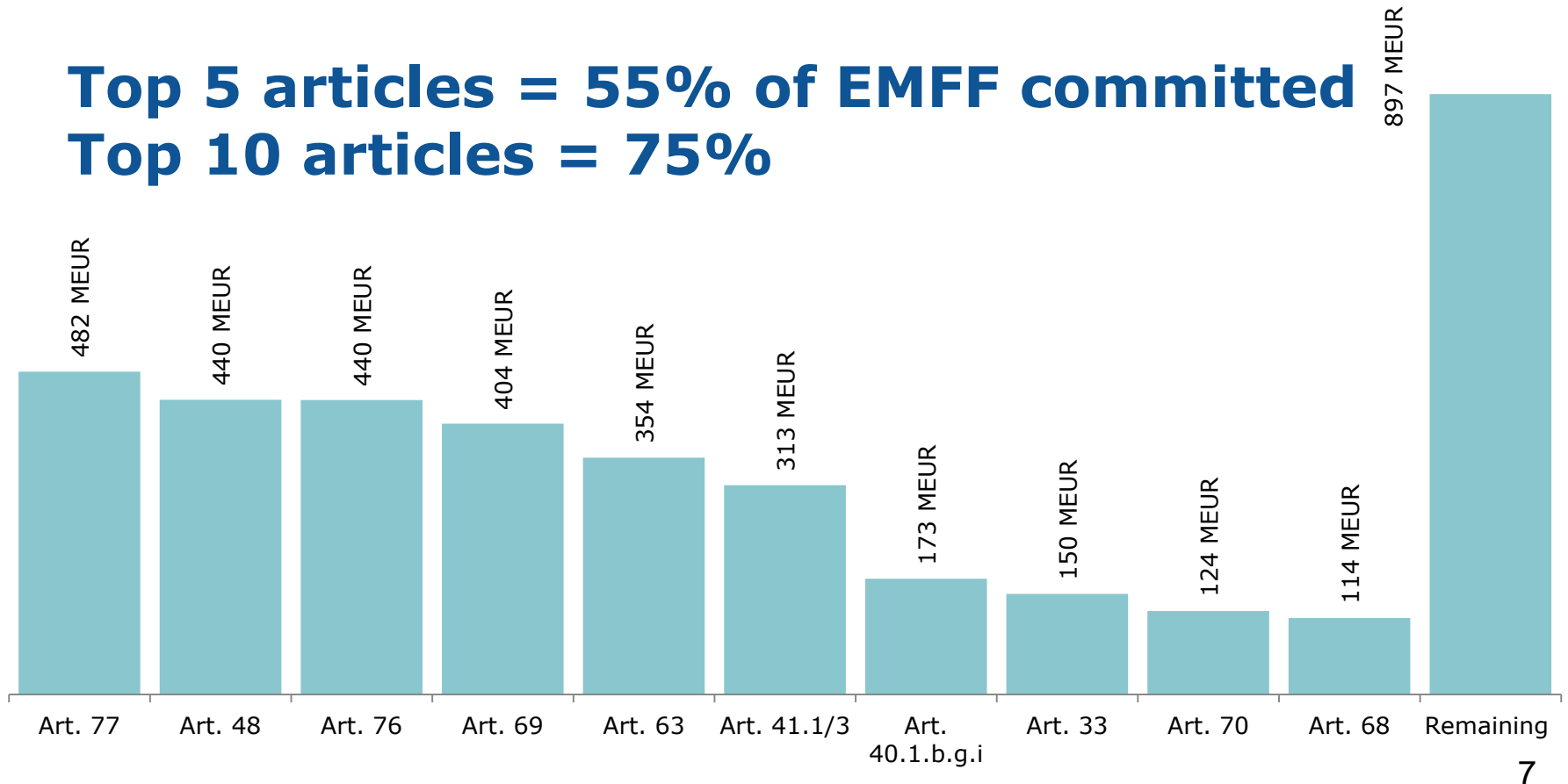

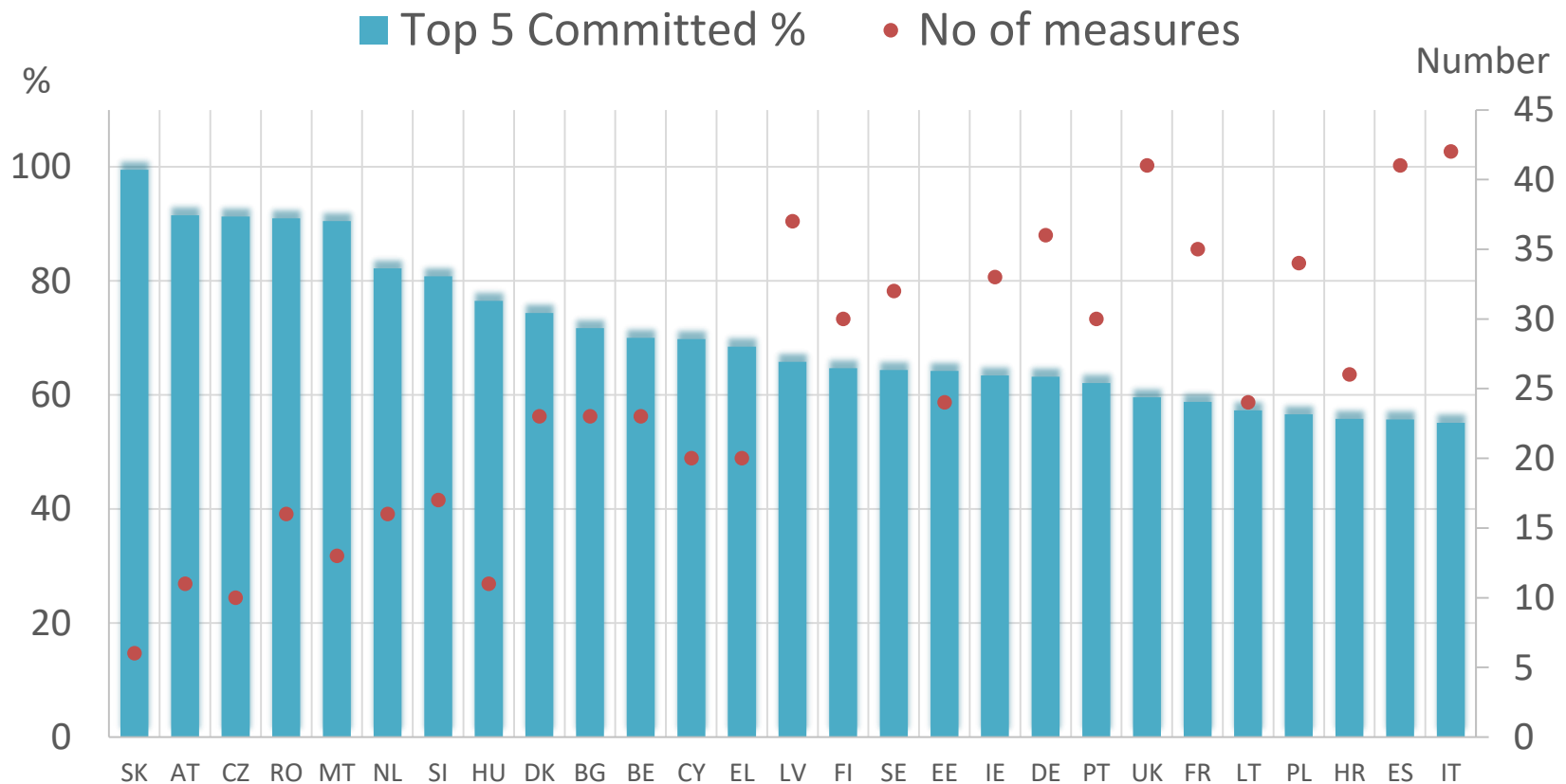
EMFF spent as percentage of total EMFF allocation – EUR 5.7 billion

EMFF committed per Article

Top 5 articles = 55% of EMFF committed
Top 10 articles = 75%



Commitments versus OP diversification



Level of OP diversification (commitments to top five measures as a percentage of total EMFF funding committed, and total number of measures in the OP)



EMFF contribution to specific topics (1) – support to fishing fleet

*EUR 671.9 million (or 16.5% of total EMFF committed) was dedicated to 35 756 **operations linked to an FFR vessel number***

*Of that, 13 580 (38.0%) operations were for **SSCF vessels***

***SSCF** received 25% of the EMFF spending dedicated to vessels (EUR 124 million out of EUR 500 million).*



EMFF contribution to specific topics (2)

*MS selected 4 111 operations related to **the landing obligation** with a total EMFF funding of EUR 147.7 million*

*In total 1 092 operations with a total EMFF budget of EUR 226.7 million were related to **innovation***

*EUR 108.7 million of the EMFF funding in 5 913 operations was committed to **mitigating the coronavirus impact***

These commitments correspond to 2.7% of total EMFF funding committed. 74.0% (EUR 80.5 million) of the funding for coronavirus support was allocated via the Article 33

The next steps

EMFF implementation report 2020 is expected to be released in October 2021.

*It will include the **synthesis of information provided in Infosys and AIR reports.***

EMFF implementation reports will continue until 2024 (two years of implementation left).
