- Following DG MARE annotated template logic (2019);
- Following section by section including:
 - suggestions
 - methodological advice related to NA 2019 workshops;
- Draft version in 2020, following CPR progress...



Working paper "simplified cost options"

- Aligning with other COM guidance and papers (DG REGIO, DG EMPL, DG AGRI)
- Making use of: EMFF 2014-2020 Infosys data, lessons learnt in ESIF, methods already applied (e.g. cessation), experts advice, preparatory steps of selected MAs;
- CPR annex programme template as the base (June 2020 version);
- No legal interpretation, FAME working paper;
- No turn-key solutions but **decision aid and criteria**, governance is very important (beneficiaries, audit authority);
- Final version in 2020, following CPR progress...



Working paper "CMES 2021-2027"

- Follows the discussion between DG MARE and Member States
- Contains two parts:
 - Explanatory part (legal background, elements of the CMES, intervention logic);
 - Fiches (common indicators definition, Infosys annexes, types of operations)
- No legal interpretation, FAME working paper;
- Final version in 2020, following trilogue progress...

 - FAME activities.




Peer review 2020 I

- Recording of sessions and access to recordings and materials for all MAs on the SharePoint MS platform.






Peer review 2020 III

The COVID video

- During the COVID lockdown everyone had to reinvent their working routines;
- Shooting FAME videos became almost impossible;
- FAME geographic experts had a crash course on journalism and video shooting and were sent to the field;
