1. AMENDMENTS IN RELATION TO ICCAT

EXPLANATORY NOTE

At its 2023 annual meeting, the International Commission for the Conservation of Atlantic Tunas (ICCAT) decided the EU quota of North Atlantic blue shark (*Prionace glauca*) for 2024, taking into account the annual transfer of 348 tonnes to the Kingdom of Morocco until the next stock assessment by the Standing Committee on Research and Statistics.

The Commission proposal, as updated by the Commission services' non-papers of 27 November 2023, 4 December 2023 and 9 December 2023¹, should therefore be updated by amending that EU quota and the Member States' quotas under that EU quota accordingly and adding a footnote to clarify that the EU quota takes into account such annual transfer.

In addition, it is proposed to delete recital (11) as it is no longer relevant.
