## Number of landings of sharks:

The total number of landings which included sharks was 444. These landings included the following species of sharks:

- picked dogfish (Squalus acanthias)
- Mediterranean starry ray (Raja asterias)
- Common eagle ray (Myliobatis Aquila)
- Smooth-hounds nei (Mustelus spp.)
- Smooth-hound (Mustelus mustelus)

Considering the number of landings, the fact should be taken into account that, in accordance with Slovenian national legislation, fishing logbooks have to be filled in by all fishing vessels, including vessels below 10 m of length, and for all species and quantities of the fisheries products caught (Regulation on the traceability of catches, Official Journal of the Republic of Slovenia No 2/13). A great majority of the landings of sharks was below 5 kg of weight.

## Number, date and place of the inspections that have been carried out:

A total of 46 inspections of landings were performed in 2014 (i.e. for all fisheries products); these were general inspections, and no non-compliance with Council Regulation (EC) No 1185/2013 or Regulation (EU) No 605/2013 was detected:

The number and nature of cases of non-compliance detected, including a full identification of the vessel(s) involved and the penalty applied for each case of non-compliance:

There were no cases of non-compliance detected with regard to the provisions of Council Regulation (EC) No 1185/2003 or Regulation (EU) No 605/2013 in Slovenia in 2014.

- Mediterranean starry ray (Raja asterias): 368,8 kg/ 139 landings
- Common eagle ray (Myliobatis Aquila): 237,6 kg/ 48 landings
- Smooth-hounds nei (Mustelus spp.): 262,53 kg/ 55 landings
- Smooth-hound (Mustelus mustelus): 1009,39 kg/ 196 landings
