1. AMENDMENTS TO ANNEX IA OF THE COMMISSION PROPOSAL

EXPLANATORY NOTE:

For Whiting in the Bay of Biscay (8), the quotas in the Commission Proposal are amended to take account of a *de minimis* deduction of 3.3%, leading to an overall reduction of 13% compared to the Union quota in 2020.

CHANGES TO ANNEX IA:

In Annex IA to the Commission Proposal COM (2020) 668, the fishing opportunities table for whiting in ICES subarea 8 is replaced by the following:

2. AMENDMENTS TO NEAFC STOCKS AND UNILATERAL QUOTAS IN THE NORTH EAST ATLANTIC

EXPLANATORY NOTE:

ICES issued scientific advice for shallow pelagic and deep pelagic redfish in ICES subareas 5, 12, and 14 and in NAFO subareas 1 and 2 for zero catches. The NEAFC Annual Meeting was prepared in the Council working party on 6 November 2020. The Annual Meeting took place on 10-13 November 2020, where NEAFC adopted a conservation measure for the two redfish stocks in the Irminger Sea and adjacent waters, prohibiting directed fisheries of those stocks. In addition, it prohibited fishing activities in the area where redfish aggregates, to minimise its by-catches.

For redfish in ICES subareas 1 and 2, the European Union submitted a proposal for a TAC of 16 540 tonnes, however, NEAFC was not able to adopt a recommendation for that stock. The Council working party was informed on the outcome of the NEAFC Annual Meeting on 26 November 2020. The Commission is proposing to set the fishing opportunities for those stocks in line with the scientific advice, the adopted NEAFC recommendation and, where no recommendation was adopted, with the EU position expressed in NEAFC.

As regards Greenland halibut in international waters of ICES subareas 1 and 2, the Commission proposes to maintain the TAC at its 2020 level of 1 800 tonnes.

1. Recital 30 is replaced by the following:

"At its annual meeting in 2020, the North-East Atlantic Fisheries Commission (NEAFC) adopted a conservation measure for the two redfish stocks in the Irminger Sea and adjacent waters, prohibiting directed fisheries of those stocks. In addition, it prohibited fishing activities in the area where redfish aggregates, to minimise its by-catches. That NEAFC measure, based on the ICES advice for zero catches, should be implemented in the Union law. NEAFC was not able to adopt a recommendation for redfish in ICES subareas 1 and 2. For that stock, the relevant TAC should be established in line with the Union position expressed in NEAFC."

2. In Chapter III, the following Section is inserted:

"SECTION 1A NEAFC CONVENTION AREA

Article 16a Closures for redfish in the Irminger

All fishing activities shall be prohibited in the area bounded by following co-ordinates measured according to the WGS84 system:
